The Principal Chief Commissioner of Income Tax, UP (West) & Uttarakhand Region, Kanpur, invites applications for the recruitment of Meritorious Sportspersons in different games/sports, notified by Department of Personnel & Training from time to time, for the following posts carrying the pay and having educational and other qualifications as listed below.

## 2. Post, Pay, Eligibility & Vacancies:

The posts are temporary but likely to be permanent. The probation period shall be for two years.

# Relaxation of age and other conditions:

- (i) In addition to the relaxation of 3 & 5 years available for OBC & SC/ST categories respectively, a special relaxation in age limit is allowed in accordance with DOPT 0m No. 2/3/84-Estt(D) dated 12.11.1987 to a maximum of 05 years for all categories of Sports Persons including General/Unreserved category.
- (ii) Relaxation of age shall be considered in respect of Ex-servicemen and PwD candidates as per the DOPT guidelines in addition to the other relaxations like community and sports persons.
- (iii) Reservation Rule is only for claiming the exemption in age relaxation. Such candidates should necessarily submit proof of age i.e. SSC Certificate and Caste Certificate for claiming exemption in age relaxation.

- (iv) The concession will be available only to those sportspersons who satisfy all other eligibility conditions relating to educational qualifications etc and furnish a certificate in the form from an authority prescribed in these instructions.
- (v) No appointment can be made unless the candidate is in all respects, eligible for appointment to the post applied for, and in particular, with regard to age, educational qualifications prescribed under the Recruitment Rules applicable to the post, except to the extent to which relaxations thereof have been permitted in respect of category of persons to which the applicant belongs.

### 3. SPORTS ELIGIBILITY

Appointments shall be made of a sportsperson who has participated in any of the games/sports (as mentioned in Para-05) and considered meritorious with reference to the following criteria:-

Sportspersons having represented:

(i) A state or the country in the National or International Competition in any of the games/sports mentioned in the list at Para-05

For the purpose of recruitment the international meets/competitions shall be categorized as under:-

Category-A : (1) Olympic Games

(2) World Championships/ World Cup

Category-B: (1) Asian Games

(2) Commonwealth Games(3) Asian Championships/ Cup

(4) Commonwealth Championships / Cup

Further, keeping in view the overall intention of the Government of India (ii) behind the recruitment through sports quota to promote and nurture sportspersons, priority shall be given to a candidate without any sponsorship/scholarship/contract/employment under central, government & PSUs over the other similarly placed candidate being in receipt monetary compensation in of the nature of sponsorship/scholarship/contract/ employment under central, state government & PSUs from any Indian/Non-Indian entity.

### 4. SELECTION OF THE CANDIDATES:

**4.1** The applications shall be scrutinized, and eligible candidates shall be shortlisted on the basis of evaluation of their performances in last **three years** (i.e. 2019 to 2021), age and highest achievement in their career in respective sports events. For this purpose, all the eligible candidates shall be called for appearance before the Committee for verification of the relevant original

documents submitted by them alongwith their applications. In this regard, only those documents whose copies are already submitted with the applications by the concerned applicant with proper attestation shall be taken into consideration by the Committee. Any other documents submitted thereafter shall not be considered.

### 4.2 Minimum Norms for Recruitment under sports quota:

Sportsperson who has any of the following sports achievement in any of the games mentioned in Para 5:

(i) Represented the country in the International Championship as mentioned in Category-A & B under Para 3 above.

# IF ADEQUATE NUMBER OF CANDIDATES ARE NOT AVAILABLE, THEN

(ii) Represented State or equivalent Unit, in Junior/Senior National Championship and obtained at least 3<sup>rd</sup> Position.

# IF ADEQUATE NUMBER OF CANDIDATES ARE NOT AVAILABLE, THEN

(iii) Represented a University, in All India Inter-University Championship, organised under the aegis of Association of Indian Universities and obtained at least **2nd Position**.

## 4.3 Note (for Para 4.1 & 4.2):

- **a.** Preference shall be given to sportspersons having higher levels of sports achievements, within the prescribed sports norms.
- **b.** For norms mentioned under Para 4.2(ii) only Senior National and Junior National Championships, shall be taken into consideration. Rural Meets, Festival Meets and other similar tournaments shall not be considered.
- c. In **Cricket (Men)** Senior Category, representation of main Indian team in a Test Match or in a One Day International Match shall also be considered for recruitment subject to condition mentioned in para 3 (ii).
- **d.** In **Cricket (Men)** Senior Category representation of a State or equivalent Unit, at least in the semi-finals of Ranji Trophy Elite Group Championship or semi-finals of Inter State All India Limited Overs Tournament (popularly known as One Day Ranji Trophy Championship), shall also be considered for recruitment subject to condition mentioned in para 3 (ii).
- **e.** In **Cricket (Men)** Junior Category representation of a State or equivalent Unit, at least in the semi-finals of Cooch Behar (U-19) and Vinoo Mankad (U-19) Championships, shall also be considered for recruitment subject to condition mentioned in para 3 (ii).

- **f.** In **Rifle Shooting**, only the **individual performance** in the championships shall be considered subject to condition mentioned in para 3 (ii).
- **g.** In **Table Tennis**, sportsperson with current All India Ranking upto **16** in Seniors and upto **8** in Juniors shall also be eligible. Only the current Annual Ranking shall be considered for this purpose subject to condition mentioned in para 3 (ii).
- h. In **Badminton**, sportsperson with current All India Ranking upto **16** in Seniors and upto **8** in Juniors shall also be eligible. Only the current Annual Ranking shall be considered for this purpose subject to condition mentioned in para 3 (ii).
- i. In **Tennis**, sportsperson with current All India Ranking upto **10** in Seniors and upto **8** in Juniors shall also be eligible. Only the current Annual Ranking shall be considered for this purpose.
- **j.** In **Golf,** sportsperson having I.G.U ranking from 1-50; and (ii) for recruitment Only the current Annual Ranking shall be considered for recruitment purpose subject to condition mentioned in para 3 (ii).
- **k.** Similarly in other sports mentioned in para 05 Sports persons having All India current Ranking (as on the date of advertisement) in seniors or juniors under 10 shall be considered for recruitment purpose subject to condition mentioned in para 3 (ii).
- **4.4** In respect of appointment to the post of Tax Assistant, the candidates shall also be required to qualify the Data Entry Speed Test, in consonance with the provisions of the relevant Recruitment Rules. Appointment of such candidates shall be made only after the Head of the Department is satisfied about the eligibility of the candidate as well as his/her suitability for the post in all respects.

7. The selected candidates on appointment will be liable for posting at any place in the UP (West) & Uttarakhand Region, Kanpur.

- 8. Selected candidates will be required to give an undertaking to the effect that they shall not apply for inter-charge transfer before rendering regular service for a minimum period of 10 years under this charge.
- 9. Sportspersons who are already employed in Central Government or State Government or PSU should attach a No Objection Certificate (NOC) from the present employer.
- 10. **Self**-attested copies of all documents in support of claim regarding the date of birth, educational qualifications, sports eligibility certificates, caste certificates, etc. should invariably accompany the application. Further, latest passport size **self**-attested colour photograph shall also be pasted on the application form in the space provided for the purpose.
- 11. Applications received after the due date shall not be entertained under any circumstances. Incomplete, unsigned applications or applications without the required annexure will be rejected summarily and no correspondence in the matter will be made with the applicant. The date and venue for verification of original documents shall be intimated to the candidates concerned in due course.
- 12. Sports achievements certified by the recognized authorities (**Annexure-III**) in specified forms (**Specimens forms given in the Annexure-V**) will only be considered.
