Application for the position of Assistant Professor (One Post) in Political Science on Contract Basis for School of Public Policy and Governance, TISS- Hyderabad Off Campus

<u>The Tata Institute of Social Sciences (www.tiss.edu)</u>, established in the year 1936 is a Deemed to be University, fully funded by the University Grants Commission, Govt of India. TISS is a Grade I University with NAAC score of 3.89/4 and is ranked 60 under NIRF University Rank Category for 2022.

With campuses at Mumbai (Main) and off-campuses at Tuljapur, Guwahati and Hyderabad, TISS offers over 52 Post Graduate programmes, 18 Doctoral programmes, and 4 Under Graduate programmes in a range of socially relevant inter-disciplinary and applied social science disciplines, and over 30 B.Voc. programmes.

Freedom and autonomy shape the positive work ethos and culture of the Institute andfacilitate strong linkages between teaching, research, field action and policy engagement. The Institute encourages and supports researchers to engage in foundational, applied, field and action-oriented research, and it also nurtures research collaborations nationally and internationally, with a commitment to creating a just society through education, generation of knowledge and field action initiatives.

The School of Public Policy and Governance (SPPG) has a mandate to create a cadre of public policy professionals who through their multi-disciplinary training respond to current policy challenges and incubate ideas to proactively meet future demands. The school provides interdisciplinary foundational training in Ethics and Policy, Economics (including econometrics), Law, Political Science, and Sociology. It encourages students to be reflexive in developing institutional designs that can transform public services. The School offers threepost-graduate courses – MA in Public Policy and Governance, MA in Cities and Governance, and PGD in Cities and Governance.

The school invites applications from interested scholars for **ONE** post of **Assistant Professor** in **Political Science** at the **School of Public Policy and Governance** to lead the teaching and research programmes in the areas of **Political Science** with a focus on public policy. The candidate should have demonstrated research interest and publications around Indian State and Political Process/Regulation and Institutions/ Welfare Regimes/ Law and Governance and other similar research areas.

Candidates who have applied to the ADVT/TISS/ACAD/AP-PS/HYD/November/2022, dated 29 November 2022 need not apply again. Their applications wll be considered as per rules.

The post will be on a contractual basis initially for a period of one year.

Pay Scale: Consolidated salary of Rs. 81,624/- p.m. (Pay Band Rs. 15,600 – 39,100/- with AGP Rs. 6,000/- in 6th CPC as approved by funder).

Educational Qualification:

Essential Qualification:

A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in **Political Science / Public Policy** from an Indian University, or an equivalent degree from an accredited foreign university.

Eligibility (A or B):

A. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree, and such Ph.D. candidates shall be exempted from the requirement of NET /SLET /SET for recruitment and appointment of Assistant Professor subject to the or equivalent positions in Universities/Colleges/Institutions fulfilment of the following conditions: -

- a) The Ph.D. degree of the candidate has been awarded in a regular mode; b) The Ph.D. thesis has been evaluated by at least two external examiners; c) An open Ph.D. viva voce of the candidate has been conducted:
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

OR

B. The Ph.D degree has been obtained from a foreign university/institution with a ranking among the top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

Desirable Qualification

The candidates having Ph.D. in **Political Science/ Public Policy** and subsequent research work focusses on the following will be preferred:

• Regulation and Institutions/ Indian State and Political Process / Welfare Regimes/ Law and Governance and other similar research areas

- Familiarity with large data sets (NSSO, Census, NFHS, etc.) and their usage to understand the contemporary state, political and the policy process
- Having the willingness to work in a team and explore new and emerging research
- Good publication records will be given preference.

The candidate selected to this position will contribute to teaching, student mentoring, and research projects at the TISS Hyderabad off-campus. Besides teaching courses across the programmes in the Institute, the candidate should also be willing to work in a team and explore new and emerging research areas. The candidate selected should be willing to take responsibility for the coordination of workshops, experiential learning and other academic administration as may be required from time to time.

Interview: The eligible candidates will be communicated by e-mail to appear for the online interview.

Application Fee: The application fee of Rs. 1000/- be paid online. The SC/ST/PWD candidates will be waived from the application fee if they attach the required certificate to the online application form. The women candidates are waived for payment of application fee. The application will be valid only on receipt of the application fee for those who are required to pay. Fees, once paid, shall not be refunded under any circumstances.

Other Conditions:

- The Institute reserves the right to relax the qualification of the candidate based on the work experience and to relax age in the case of persons already holding comparable positions in a University/Research Institution of repute.
- The Institute reserves the right to invite persons for interview who may not have applied foras per the above procedure and not fill up the vacancy advertised.
- Since applications received may be short-listed, merely possessing the prescribed qualifications and the requisite experience would not entitle a person to be called for interview.
- The post is unreserved, but candidates belonging to reserved category can apply.
